#### **Preamble**

The Rashtriya Jankranti Morcha (RJM), established on November 27, 2011, in Chatra, Jharkhand, is committed to equitable development, social justice, and the empowerment of marginalized communities. As a political party registered with the Election Commission of India under Section 29A of the Representation of the People Act, 1951, RJM pledges to uphold the Constitution of India, promote secularism, and foster inclusive growth in Jharkhand.

## 1 Name and Registration

- 1. Name: The party shall be known as Rashtriya Jankranti Morcha (RJM).
- 2. **Registration**: RJM is registered with the Election Commission of India as an unrecognized political party since 2014.
- 3. **Headquarters**: The registered office is located at Hussain Nagar, Isri Bazar, Dumri, Isri, Jharkhand 825167.

### 2 Objectives

The primary objectives of RJM are:

- 1. To promote equitable development in Jharkhand, ensuring access to quality education, healthcare, and employment opportunities for all citizens.
- 2. To empower marginalized communities, including tribal and minority groups, through inclusive policies and representation.
- 3. To protect Jharkhand's natural resources and promote sustainable development for environmental and economic resilience.
- 4. To strengthen local governance by ensuring transparency, accountability, and community participation in public services.
- 5. To uphold the principles of secularism, democracy, and social justice as enshrined in the Constitution of India.

## 3 Membership

1. **Eligibility**: Any Indian citizen aged 18 or above who subscribes to RJM's objectives and pays the prescribed membership fee is eligible to apply.

### 2. Types of Membership:

- *Primary Membership*: Open to all eligible individuals upon payment of the annual fee.
- Active Membership: Granted to primary members who actively participate in party activities for at least one year and are approved by the State Executive Committee.

- 3. **Application Process**: Membership applications are submitted to the District Committee and approved by the State Executive Committee.
- 4. **Renewal**: Membership must be renewed annually. Non-renewal results in lapse of membership.
- 5. **Termination**: Membership may be terminated for anti-party activities, violation of this constitution, or failure to adhere to ECI regulations, as decided by the National Executive Committee.

### 4 Organizational Structure

#### 1. National Level:

- *National Executive Committee*: The apex decision-making body, responsible for policy formulation and national operations, chaired by the President.
- *President*: Abdul Mobin Rizvi, elected for a three-year term, leads the party and represents it in official matters.
- Secretary: Md Mahmood Alam, responsible for administrative coordination and record-keeping.
- *Treasurer*: Jamaluddin Ansari, manages financial accounts and ensures compliance with ECI financial regulations.

#### 2. State Level:

• *State Executive Committee*: Oversees state-level activities, led by the State President, appointed by the National Executive Committee.

#### 3. District and Block Levels:

- *District Committees*: Coordinate local campaigns, membership drives, and voter outreach, led by District Presidents.
- *Block Committees*: Support grassroots activities under the guidance of District Committees.

## 5 Financial Management

1. **Sources of Funds**: RJM raises funds through membership fees, voluntary donations, and contributions, in compliance with ECI regulations.

#### 2. Transparency:

- Annual audited accounts are prepared and submitted to the ECI.
- Contribution reports (Form 24A) are filed as per ECI guidelines and published on the RJM website (https://rajmo.in/financials.html).
- 3. **Bank Account**: All funds are deposited in a designated bank account, managed by the Treasurer, with transactions reported to the ECI.

4. **Audit**: An independent auditor, approved by the National Executive Committee, conducts annual financial audits.

#### 6 Elections and Candidate Selection

- 1. **Internal Elections**: Office-bearers at national, state, and district levels are elected every three years through a democratic process supervised by the National Executive Committee.
- 2. **Candidate Selection for Public Elections**: Candidates for Lok Sabha, Vidhan Sabha, and local elections are selected by the National Executive Committee based on recommendations from State and District Committees, ensuring alignment with RJM's objectives.
- 3. **Election Symbol**: As an RUPP, RJM uses free election symbols assigned by the ECI, which are prominently displayed in campaign materials to avoid voter confusion.

### 7 Discipline

- 1. **Conduct**: Members must adhere to RJM's objectives, this constitution, and ECI regulations, refraining from activities that harm the party's reputation.
- 2. **Disciplinary Action**: Violations, including anti-party activities, are investigated by a Disciplinary Committee appointed by the National Executive Committee. Actions may include suspension or expulsion after a fair hearing.
- 3. **Appeals**: Members may appeal disciplinary decisions to the National Executive Committee within 30 days.

#### 8 Amendments

- 1. **Procedure**: This constitution may be amended by a two-thirds majority vote of the National Executive Committee, subject to ECI approval.
- 2. **Notification**: Proposed amendments must be circulated to all State Executive Committees at least 30 days prior to the vote.
- 3. **Approval**: Amendments take effect only after ECI confirmation and publication on the RJM website.

# 9 Compliance with ECI

#### RJM commits to:

1. Submitting annual reports, audited accounts, and contribution details (Form 24A) to the ECI as per statutory requirements.

- 2. Maintaining transparency in all financial, organizational, and electoral activities.
- 3. Upholding the democratic, secular, and socialist principles of the Constitution of India.
